Job Summary

This position supports the California Department of Public Health's (CDPH) mission and strategic plan by protecting the public's health, promoting health and wellness, increasing health equity, and enhancing oral health services throughout California.

The State Dental Director leads the development and implementation of oral health initiatives,

development and management of oral health programs, collaboration with internal and external partners including other State Agencies and the Department of Health Care Services (DHCS) Medicaid dental program, oversight of the analysis and publication of oral health information and communication with the public. Directs and oversees updates to the State Oral Health Plan that addresses the burden of oral disease and health equity, sets oral health goals, evidence-based strategies, and SMART objectives, and aligns with the Department's mission. In collaboration with state and local partners, the Director accelerates health equity in oral health by prioritizing resources to communities with the greatest inequities in oral health and social outcomes, including tribal and rural communities.

The incumbent works under the general direction of the Assistant Deputy Director, Chronic Disease Prevention within the Center for Healthy Communities. Travel is required both in and out of the state to attend and make presentations at conferences, meet with other oral health programs and national associations 10-15% of the time.

Essential Functions (including percentage of time)

Plan, organize and direct the Office of Oral Health in the California Department of Public Health to establish and implement statewide policy. Identify resources to address oral health needs, respond to funding opportunities, mobilize external stakeholders to leverage resources and serve as principal investigator of grants. Accelerate health equity in oral health by prioritizing resources to communities with the greatest inequities in oral health and social outcomes, including tribal and rural communities. Prepare budget change proposals, legislative proposals, bill analyses and grant applications/progress reports. Oversee compliance with fiscal requirements and assure program deliverables are achieved. Oversee evaluation of programs. Recruit, hire and supervise program professional and administrative staff, according to state personnel guidelines.

Convene statewide oral health stakeholders and provide backbone oversight for the California Partnership for Oral Health (CPOH). Collaborate with dental and oral health programs in other state agencies, including the Department of Health Care Services (DHCS) Medicaid dental program. Work with DHCS in DHCS' efforts to identify and address issues and program improvements in the Medicaid dental program and dental managed care health plans. With stakeholder input, update and publish the state Oral Health Plan that addresses the burden of oral disease and health equity, set oral health

goals, evidence-based strategies, and SMART objectives, and aligns with the Let's Gets Healthy California Goals. Working with CDPH and DHCS, and the CPOH Steering Committee, monitor the California Oral Health Plan for progress on goals and objectives, and implement state-level oral health interventions and activities as funding allows.

- Update and publish the Oral Health Burden of Disease Report, oversee the planning for, collection and analysis of oral health data (including oral health surveillance), and publish information in reports and articles about the state of oral health in California. Identify oral health issues, gaps and needs, including inequitable outcomes along racial/ethnic, geographic, and other relevant domains. Translate this information and communicate it effectively to internal and external stakeholders and the public on a regular basis. Serve on workgroups, taskforces, and state and national organizations that address oral health; attend CDC, and HRSA, CMS, NIDCR, and ASTDD conferences and trainings. Attend CHC Chief Meetings and the California Conference for Local Health Officer meetings as well as other Center or Department required meetings.
- 10% Coordinate with other programs within CDPH including chronic disease; school health; maternal, child, and adolescent health; WIC; health equity and DHCS Medicaid dental program to prevent chronic disease, including oral diseases, with a focus on disease surveillance, health and dental care systems, clinical community linkages, and policy, environmental and systems change initiatives.
- Provide training and technical assistance on oral health issues, including review of oral health programs in local health agencies, to internal and external partners and stakeholders at the state and local level, such as the California Dental Board, State Water Resources Control Board, Department of Developmental Services, Office of Aging, CDPH Healthcare-Associated Infections (HAI) Program, CAL/OSHA on the topics of infection control practices, evidence-based public health and population health interventions, and the integration of clinical and public health services. Share evidence-based strategies and best practice approaches.
- Maintain professional competence by continual review of scientific and technical literature and attendance at professional conferences and symposia. Maintain advanced level of competency in the field of public health, population health, and dental public health domains, in accordance with the Association of State and Territorial Dental Directors Oral Health Program (S/TOHP) Competencies. Maintain dental licensure in California.
