Job Summary

This position supports the California Department of Public Health's (CDPH) mission and strategic plan by improving the health and wellbeing of children born with inheritable diseases and reducing the burden of patients and families through early detection.

The incumbent works under the general supervision of the Research Scientist Supervisor I (Epidemiology/Biostatistics), Chief of the Newborn Outcomes and Evaluation Unit. The Research Scientist (RS) II (Epidemiology/Biostatistics) manages and oversees newborn screening data

collection for genetic diseases, with focus on but not limited to severe combined immunodeficiency disorder, X-linked adrenoleukodystrophy, endocrine disorders, and NBS disorders that are detectable through MS/MS testing. Disease assignment and focus is based on emerging priorities in the Unit and can change. The incumbent plans, organizes and carries out research and data linkage projects to evaluate and improve the screening and follow-up performances for various type of disorders. The RS II will generate newborn screening epidemiological results and provide periodical reports to statewide newborn screening stakeholders.

Essential Functions (including percentage of time)

- 35% Plan, design, organize, and carry out scientific evaluation research of moderately developed scope and complexity in newborn screening (NBS) of genetic diseases, with the focus on the surveillance of severe combined immunodeficiency disorder, X-linked adrenoleukodystrophy, endocrine disorders, and NBS disorders that are detectable through MS/MS testing. Lead or assist surveillance activities in other disorders as needed. Participate in designing and organizing epidemiological research to enhance screening performance. Monitor, collect and analyze both population-based screening data and clinical confirmatory testing results data, and study confirmed cases in the registry to evaluate current screening outcomes.
- 25% Plan, organize and carry out evaluation research of moderate complexity in newborn screening follow-up (both short-term and long-term) services. Work closely with NBS program staff to design and modify collection instrument and protocol for outcome and long-term follow-up data. Participate in analysis and management of short-term and long-term follow-up information to identify areas of improvement. Link birth, death, and Medi-Cal data to improve case reporting and long-term follow-up services for all NBS disorders.
- 20% Lead the plan, design, and data analysis of periodical NBS data reporting. Work with NBS program staff to identify reporting needs. Lead the NBS data visualization efforts, setting up workflow, managing and organizing data visualization projects.
- 10% Coordinate internal and external data request projects and take the lead on responding to requests as needed.

Marginal Functions (including percentage of time)

- 5% Provide technical assistance on epidemiological aspects of the NBS. Participate in workgroups on special projects within the program. Perform other work-related duties as assigned.

5% Miscellaneous projects, activities, and tasks that move the GDSP closer to the Department’s priorities related to diversity, inclusion, and belonging; healing; continuous and shared learning; and racial and health equity.
