General Statement

Under the close supervision of a Senior Environmental Scientist and consistent with good customer service practices and the goals of the State and Regional Board's Strategic Plan, the incumbent is expected to be courteous and provide timely responses to internal/external customers, follow through on commitments, and to solicit and consider internal/external customer input when completing work assignments.

Position Description

The Environmental Scientist classification performs scientific office and field work. Office work includes research and data collection on environmental and natural resource management for use in reports such as Total Maximum Daily Loads or Basin Plan Amendments. In addition, Environmental Scientists perform data analysis, investigations, or studies pertaining to the development and implementation of orders or the Basin Plan. This position is public facing with some correspondence occurring between government entities, non-governmental organizations, and the public.

Typical Physical Conditions/Demands:

The job requires extensive use of a personal computer and the ability to sit/stand at a desk, utilize a phone, and type on a keyboard for extended periods of time. Ability to lift 15 pounds, bend and reach above shoulders to retrieve files and/or documents. Site visits may involve navigating uneven, rugged terrain for extended periods of time, in extreme temperatures throughout the workday.

Typical Working Conditions:

This is a hybrid position. The incumbent works on the first floor of an office building in central Palm Desert, in an enclosed, non-windowed office cubicle in a smoke-free environment when in the office. The incumbent also has a workspace in a secondary location, typically their home that is set up much like the state office. The work schedule is Monday through Friday. Travel may be required locally and within the state. Occaisonally staff may be asked to attend outreach events on weekends or outside of normal work hours.
