<u>MISSION OF SECTION</u>: The Diesel Programs Enforcement Branch (DPEB) is responsible for enforcement of California's on and off-road diesel regulations and programs. Examples include the Statewide Truck and Bus, Off-Road Equipment, and Transport Refrigeration Unit Regulations, and the Periodic Smoke Inspection, Verified Diesel Emissions Control Strategies (VDECS), and Heavy-Duty Vehicle Inspection Programs.

The Data Operations Section (DOS) is primarily responsible for developing data-driven enforcement processes, tracking tools, and enforcement reporting systems to improve the efficiency and transparency of CARB's enforcement programs. DOS develops, deploys, and maintains the Remote Emission Monitoring and Enforcement System (REMES), the Enforcement Data Visualization System (EDSS), and provides operational, technical, and enforcement support for the use of Remote Emissions Monitoring Devices. DOS develops and maintains a division-wide data warehouse for streamlined reporting, as well as dashboards to share data both within CARB and publicly on the CARB website. The programmatic responsibilities of DOS will evolve over time as current programs mature and new programs are implemented.

<u>CONCEPT OF POSITION</u>: The Air Resources Supervisor I is a first level supervisory position. Under the general direction of the Diesel Programs Enforcement Branch Chief, an Air Resources Supervisor II, the incumbent is responsible for overseeing the branch's data development platforms, streamlined enforcement processes, technology development, remote emissions measurement equipment and processes, and related enforcement services and activities of DOS staff. Additionally, the incumbent assists the Branch Chief with a broad range of general program and workforce management activities, including providing input to the regulatory development process to it aligns with data development needs, developing enforcement strategies and plans, developing and reviewing legislative and budget proposals, budgeting, recruiting and hiring new staff, conducting regular case review meetings, completing probation reviews and annual staff performance reviews, and preparing monthly, quarterly, and annual program status and performance reports.

Finally, the incumbent assists the Branch Chief with activities involving other government agencies at the local, regional, state, federal, and international levels, non-governmental and media organizations, private industry groups, and the general public. Travel may be required up to 25%.
