Job Summary

This position supports the California Department of Public Health's (CDPH) mission and strategic plan by advancing the health and well-being of California's diverse people and communities. As an employee of the Local Policy and Health Programs Branch, the incumbent leads a team that provides support, training, and implements local and statewide policies which protect and serve the Women, Infants, and Children (WIC) Program participants and local agencies.

The incumbent works under the general supervision of the Chief, Health and Nutrition Education Section, Health Program Manager II (HPM II). The Public Health Nutrition Consultant III (PHNC III)

(Specialist) serves as a highly skilled nutrition and program services professional responsible for assessing the effectiveness and quality of nutrition and program services provided by WIC local agencies to pregnant, breastfeeding, and postpartum women, infants, and children; and evaluating the implementation of federal and state policies by WIC local agencies. Leads the development, coordination, implementation and evaluation of nutrition and program services to meet the needs of participants, as well as complex, comprehensive state-wide nutrition, breastfeeding and training campaigns, projects, and initiatives. Travels statewide up to 25% of the time.

Essential Functions (including percentage of time)

- 40% Serves as lead on development, implementation, and evaluation of comprehensive, complex, and difficult state-wide education, breastfeeding and training campaigns, projects, and initiatives, which can include social media messages, education materials, and website content. Reviews and develops content and materials using plain language skills and evaluates literacy levels for division wide materials and messages. Works collaboratively with the Communications, Food, and Vendor Policy Branch
- 40% Researches medical and behavioral literature; develops, revises, and edits education materials and curricula, reports, memorandums, issue papers, and budget proposals on complex subjects pertaining to public health nutrition. Provides subject matter expertise within the WIC Division, partners, and other CDPH programs, WIC programs in other states, and external stakeholders. Provides legislative bill analysis on nutrition and breastfeeding-related issues.
- 10% Monitors, analyzes, and makes recommendations on national and state nutrition guidelines related to the WIC Program. Reviews trends in program and nutrition-related issues in local WIC agencies and advises the WIC Division and WIC local agencies on high priority issues.
- 5% Represents WIC across CDPH and related department meetings, workgroups, and committees. Serves as liaison with other preventive health and health programs within state and local health agencies, departments, and programs, and provides overall leadership on nutrition and program issues to reduce nutrition and program risk factors.
