MISSION OF SECTION: The Central Valley Air Quality Planning Section (CVAQPS) is responsible for all air quality planning issues related to the San Joaquin Valley as well as certain other areas of the State, e.g., Imperial County, and for ozone planning issues related to the central and northern portions of the State. The section is the lead in the preparation of PM2.5 State Implementation Plan (SIPs), PM10 SIPs, and PM-related technical and policy papers. The CVAQPS also assesses air quality data related to air quality planning, including the interactions between PM2.5 and PM10 air quality data, meteorology, and emissions in support of regulatory actions to meet ambient air quality standards for particulate matter. The section reviews particulate matter data and policy associated with exceedances of air quality standards resulting from natural events for the purpose of requesting U.S. EPA approval to exclude those data from regulatory determinations affecting air quality planning. The CVAQPS works with divisions throughout CARB, as well as with local air districts, U.S. EPA, and various public and private stakeholder groups.

CONCEPT OF POSITION: Under general direction of the Air Resources Supervisor I, the incumbent will use scientific and analytical principles and practices to support the development of effective policies, plans, strategies, and projects, either on an individual basis or as part of a team. The incumbent will provide air quality planning, analysis, and policy input by 1) analyzing data and other information submitted by local air districts in SIP submittals for validity, scientific defensibility, and regulatory compliance; 2) conducting data analyses in response to planning-related inquiries by other Branches, other CARB Divisions, local, state or federal agencies, stakeholder groups, or the public; 3) developing written reports and correspondence on technical and/or policy issues as they pertain to SIPs or other air quality planning related inquiries. Position requires the ability to think creatively using innovative approaches to address complex regulatory and policy questions. Specific duties include:
