## **Job Summary**

This position supports the California Department of Public Health's (CDPH) mission and strategic plan by optimizing data and technology for the California Reportable Disease Information Exchange (CalREDIE) program.

The Health Data Analytics Specialist ensures that laboratories conducting testing for communicable disease conditions in accordance with Title 17 CCR, Section 2505 are sending test results to public health, with timely and complete reports. Position tasks include independently collecting, managing,

and analyzing electronic lab reporting (ELR) data from various data warehouses, evaluating Health Level 7 (HL7) messages, assisting with interface configuration, presenting findings, and communicating with laboratories, local health jurisdictions, CDPH teams and vendor partners as needed to resolve identified issues. The position will assist with onboarding and validation testing for data submitters as well as with other research, reporting and data science projects for the unit.

The incumbent works under the general direction of the Research Data Manager, Chief of the Lab Reporting Team.

- Independently analyze incoming laboratory result data and extract report data, ensuring compliance with reporting specifications and Title 17 Section 2505 regulations for quality assurance. Review HL7 message structure and content with minimal oversight, identifying and resolving collection, reporting issues, and/or transmission anomalies. Conduct data analyses using ad-hoc queries and other tools to determine compliance among laboratories compiling findings on incorrect or missing codes, demographics, test details, and other discrepancies. Consider root causes of data quality issues and develop quality checks, procedures, and educational aids to mitigate future issues. Collaborate with laboratories and vendor partners to achieve compliance.
- Evaluate new lab data submitters and those with system changes to support onboarding to CalREDIE in a timely manner. Understand and communicate with laboratories on reporting channels and appropriate interface connection options to align with state operations. Utilize CDPH specification documentation, tracking tools and data visualization dashboards to guide vendor partners in ensuring reporting standards are met for all data submitters.
- 15% Provide subject matter expertise to program staff within the team and to other stakeholders, including disease control and informatics branch staff, epidemiologists at the state and local levels, laboratory technicians, IT staff, and vendor partners. Develop and build skills through training and individual research. Make recommendations to improve existing research tools and methods to expand team knowledge and address changes in the reporting and collection of data.
- 15% Effectively utilize multitasking, problem-solving and planning/organizational skills in a highly complex environment requiring attention to detail and focus on several concurrent projects with multiple deadlines. Establish and maintain reliable, efficient, and effective methods for tracking

issues and communicating with involved partners, both verbally and in writing. Document and communicate identified issues succinctly, escalating as needed.
