Once your application has been received and verified, you will be emailed the link to the Training and Experience Questionnaire. Please be sure to include your current email address on your application. Applications may also be mailed. Incomplete applications will not be accepted.

## **POSITION STATEMENT**

The Wildlife Habitat Supervisor II manages a large wildlife management area or the game farm. Incumbents on wildlife management areas or involved in habitat improvement may require the planning, supervision and performance of such activities as construction and maintenance of roads, water control systems, buildings, pens, fencing and sanitary facilities; habitat development work, including cultivating, planting, irrigating, vegetation control and marsh management; and management of public use activities including hunting and fishing. Incumbents at the game farm manage the breeding, incubation, and rearing of game birds for use on public lands and land owned by cooperating private organizations and experiment in breeding and rearing exotic game birds. Incumbents may be required to supervise inmate, ecology corps or volunteer crews; prepare budgets, reports, work schedules, requisitions, and personnel documents; and attend and speak before meetings of civic, conservation, and sportspersons groups, landowners and other public agencies; and do other related work.

## **ELIGIBLE LIST INFORMATION**

An open eligible list for the Wildlife Habitat Supervisor II classification will be established for the Department of Fish and Wildlife.

Eligibility expires 24 months after it is established. Applicants must then re-take the examination to reestablish eligibility. This examination will be administered on a continuous basis. Applicants will have the option of retesting after a 6-month testing period. Competitors choosing to retest and who are successful in the examination will be merged onto the list in order of final score. The highest score takes precedence regardless of examination date.

#### **REQUIREMENTS FOR ADMITTANCE TO THE EXAMINATION**

All applicants must meet the minimum qualifications by the application submission date.

#### **MINIMUM QUALIFICATIONS**

Qualifying experience may be combined on a proportionate basis if the requirements stated below include more than one pattern and are distinguished as Either "I", "II", or "III", etc. For example, candidates possessing qualifying experience amounting to 50% of the required time in Pattern I, and additional experience amounting to 50% of the required time of Pattern II, may be admitted to an examination as meeting 100% of the overall experience.

Applications and any attached resumes require employment history information including "to" and "from" dates (month/day/year), time base, and if applicable, civil service class titles. Applications and any attached resumes received without this information MAY BE REJECTED BECAUSE OF INCOMPLETE INFORMATION.

### <u>Either I</u>

One year of experience in the California state service performing the duties of Wildlife Habitat Supervisor I.

#### <u>Or</u>

Two years of experience in the California state service performing the duties of a Wildlife Habitat Assistant.

## <u>Or II</u>

Five years of experience in the natural resources field such as fish and wildlife, parks, or forestry performing construction and maintenance work on habitat development projects. At least three years of this experience must have been in a supervisory capacity. (Experience in the California state service applied toward this specialized three years of experience must have been in a class with a level of responsibility at least equivalent to Wildlife Habitat Supervisor I).

This examination consists of a Training and Experience Questionnaire and is the sole component of the examination. To obtain a position on the eligible list, you must attain a minimum rating of **70%**.

# COMPETITORS WHO DO NOT COMPLETE THE TRAINING AND EXPERIENCE QUESTIONNAIRE WILL BE DISQUALIFIED.

Applicants who meet the minimum qualifications for the Wildlife Habitat Supervisor II will be sent a link through email to complete the Training and Experience Questionnaire.

### PREPARING FOR EXAMINATION

Below is a list of suggested resources to have available prior to taking the exam.

**EMPLOYMENT HISTORY:** Employment dates, job titles, organization names and addresses, names of supervisors or persons who can verify your job responsibilities, and phone numbers of persons listed above.

**EDUCATION:** School names and addresses, degree earned, dates attended, courses taken (verifiable on a transcript), persons or office who can verify education, and phone numbers of persons or offices listed above.

**TRAINING:** Class titles, certifications received, names of persons who can verify your training, and phone numbers of persons listed above.

## **KNOWLEDGE AND ABILITIES**

#### Knowledge of:

- 1. Wildlife food and cover requirements, wildlife habitat improvement methods and techniques.
- 2. Construction, installation, and maintenance of road, buildings, enclosures, water control systems, and wildlife watering devices.
- 3. Soils and land uses, farming and marsh management practices, farming equipment, machinery, tools and vehicles.
- 4. Wildlife management activities in California.
- 5. Principles of supervision and safety.
- 6. The Department's Equal Opportunity Program (e.g. Bilingual Services Program, Limited Exam and Appointment Program (LEAP), Reasonable Accommodation, Sexual Harassment, and discrimination complaint process) objectives.

#### Ability to:

- 1. Read and write English at a level required for successful job performance.
- 2. Plan, organize, and direct the work of others.
- 3. Analyze situations accurately and take effective action.
- 4. Supervise and perform a wide variety of work, including farming, construction, marsh management, and public use management.
- 5. Prepare routine reports.
- 6. Maintain cooperative relations with those contacted in the work.
- 7. Develop creative programs in keeping with the goals of the organization.
- 8. Prepare budgets and program plans.
- 9. Speak effectively to interested groups and organizations.
- 10. Effectively contribute to the Department's Equal Opportunity Program (e.g. Bilingual Services Program, Limited Exam and Appointment Program (LEAP), Reasonable Accommodation, Sexual Harassment, and discrimination complaint process) objectives.

#### **GENERAL INFORMATION**

**For an examination without a written feature**, it is the candidate's responsibility to contact Department of Fish and Wildlife three weeks after the final filing date if he/she has not received his/her notice.

**Examination and/or Employment Application (STD 678)** <u>https://jobs.ca.gov/pdf/STD678.pdf</u> forms are available at the California Department of Human Resources offices, local offices of the Employment Development Department, and through your **CalCareer Account**.

**Remember, Examinations are Competitive:** If you possess the entrance requirements stated on this bulletin, you may take this competitive examination; however, you aren't assured a place on the eligibility list. Your performance in the examination is compared to established rating criteria. All candidates who pass are ranked according to their scores.

**Candidates needing special testing arrangements** due to a disability must mark the appropriate box on the application and/or contact the testing department.

**General Qualifications:** Candidates must possess essential personal qualifications including integrity, initiative, dependability, good judgment, and ability to work cooperatively with others; and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

**Eligible Lists:** Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) service-wide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

**If High School Equivalence is Required:** Equivalence to completion of the 12th grade may be demonstrated in any one of the following ways:1) passing the General Educational Development (GED) Test; 2) completion of 12 semester units of college work; 3) certification from the State Department of Education, a local school board, or high school authorities that the candidate is considered to have education equivalent to graduation from high school; 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.

**Veterans' Preference:** Will be awarded in this examination, pursuant to Government Code Section 18973.1, effective January 1, 2014, as follows: (1) Any veteran, widow or widower of a veteran, or spouse of a 100 percent disabled veteran, who achieves a passing score in an entrance examination, shall be ranked in the top rank of the resulting eligibility list. Any veteran who has been dishonorably discharged or released is not eligible for veteran's preference. (2) An entrance examination is defined, under the law, as any open competitive examination. (3) Veterans Preference is not granted once a person achieves permanent civil service status.
