MINIMUM QUALIFICATIONS

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be accepted into the examination. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

Either I

One year of experience in the California state service performing the duties of an Air Resources Technician I, Range B.

Or II

Experience: Three years of paraprofessional air pollution or vehicle emissions control experience.

Or III

Education: Completion of three years of full-time college with course work in mathematics, physical and/or natural sciences; or trade school education in electronics, auto mechanics or related fields.

POSITION DESCRIPTION

Air Resources Technician 2

This is the full journeyperson level. Incumbents are assigned the more complex and difficult paraprofessional air pollution and vehicle emissions control work.

EXAMINATION SCOPE

This examination consists of the following components:

Training and Experience Evaluation – Weighted 100% of the final score.

The examination will consist solely of a **Training and Experience Evaluation**. To obtain a position on the eligible list, a minimum score of 70% must be received. Applicants will receive their score upon completion of the Training and Experience Evaluation process.

A final score of 70% must be attained to be placed on the eligible list.

In addition to evaluating applicants' relative knowledge, skills, and ability, as demonstrated by quality and breadth of education and/or experience, emphasis in each exam component will be measuring competitively, relative job demands, each applicant's:

Knowledge of:

1. Arithmetic, spelling, grammar and English composition.

- 2. Basic statistical and mathematical computational techniques.
- 3. Emissions sources.
- 4. Air quality investigative techniques.
- 5. Ambient air monitoring, source testing and field sampling techniques.
- 6. Basic statistical and mathematical computational techniques.
- 7. Federal, State, and local air quality regulations.
- 8. Vehicular emissions control systems; air pollution control principles.

Ability to:

- 1. Learn rapidly.
- 2. Follow directions.
- 3. Communicate effectively and establish cooperative relations with other staff and those contacted in the work.
- 4. Acquire acceptable work habits such as punctuality, skill, neatness, and dependability.
- 5. Work safely.
- 6. Make satisfactory progress in a prescribed practical work-training program.
- 7. Analyze situations accurately and adopt an effective course of action.
- 8. Speak and write effectively.
- 9. Gather, compute, and analyze scientific data.
- 10. Review, check, and interpret air quality data, regulations, and maintenance and monitoring plans.

ELIGIBLE LIST INFORMATION

A departmental, open eligible list for the **Air Resources Technician 2** classification will be established for:

The names of **successful** competitors will be merged onto the eligible list in order of final score regardless of exam date. Eligibility expires **twelve (12) months** after it is established. Applicants must then retake the examination to reestablish eligibility.

Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

GENERAL INFORMATION

Examination and/or Employment Application (STD 678) forms are available at the California Department of Human Resources, local offices of the Employment Development Department, and through your <u>CalCareer Account.</u>

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described in this

bulletin will be rated against a predetermined job-related rating, and all applicants who pass will be ranked according to their score.

The Air Resources Board reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

General Qualifications: Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

High School Equivalence: Equivalence to completion of the 12th grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification form the State Department of Education, a local school board, or high school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.
