**DO NOT SUBMIT A STATE APPLICATION (STD. 678) TO THE CALIFORNIA DEPARTMENT OF HUMAN RESOURCES.**

**EXAMINATION** A candidate may be tested only once during any testing period. The testing period for this classification is once every 3 months. If you have taken an examination for this classification with the Department of State Hospitals- Atascadero, Coalinga, Metropolitan, Napa, Patton, and Sacramento within the last 3 months, you are not eligible to compete in this examination.

<b>REQUIREMENTS FOR ADMITTANCE TO THE EXAMINATION</b>	It is your responsibility to make sure you meet the education and/or experience requirements stated on this announcement on the date you submit your application. Your signature on your State Application (STD. 678) indicates that you have <u>read</u> , <u>understood</u> , and <u>possess</u> the basic qualifications required.  <b>NOTE: All applicants must meet the education and/or experience requirements for this examination by the testing deadline established by the testing office.</b>
<b>MINIMUM QUALIFICATIONS</b>	Possession of a valid license as a registered nurse and a valid certificate as a public health nurse in California. (Applicants who do not meet these requirements will be admitted to the examination, but they must secure the required license and certificate before they will be considered eligible for appointment. <b>and</b>  <b><u>Either I</u></b> One year of experience performing the duties of a Public Health Nurse I in the California state service.  <b><u>Or II</u></b> <u>Experience:</u> Two years of experience as a public health nurse in a generalized public health nursing program. <b>and</b>  <u>Education:</u> Completion of a university or collegiate program of study approved for public health nursing.
<b>SPECIAL PERSONAL CHARACTERISTICS</b>	Pleasing personality and appearance; discretion; willingness to live and work in a rural area or in an institutional facility; willingness to travel.
<b>JOB DESCRIPTION</b>	Under general direction, to plan and provide public health nursing services for a local public agency contacting with the Department of Health Services for health services; or to provide equivalent services within the Department of Health Services or to another State agency; and to do other work as required.

To obtain a position on the eligible list, a minimum score of 70% must be received. An applicant will receive his/her score upon completion of the Training and Experience Examination process.</b></p>
<b>EXAMINATION SCOPE</b>	<b>Knowledge of:</b> <ol style="list-style-type: none"><li>1. Principles and practices of nursing as applied to public health practice, and preventive medicine and sanitation.</li><li>2. Community aspects of nursing programs including provisions for continuity of patient care, nursing services in school health programs, and nursing care in the home including teaching the preventive aspects.</li><li>3. Causes and means of transmission and methods of control of communicable diseases, including tuberculosis and venereal disease.</li></ol>

4. Child growth and development and procedures involved in promoting maternal and child health and in providing for health needs of the school child.
5. Principles and purposes of public health programs.
6. Environmental, sociological, and psychological problems encountered in carrying on a rural health program.
7. Current literature and trends in public health nursing.
8. Work of other social and health agencies and functions of other professions as related to public health nursing.
9. Sociological and emotional problems involved in care of handicapped and crippled children and other afflicted persons and those accompanying the occurrence of tuberculosis, venereal disease, and chronic diseases.
10. Principles of mental health.

**Ability to:**

1. Exercise independent judgment and plan, organize, and carry out community public health nursing activities in a local area or in an institution.
2. Work effectively with individuals or families to assist them in satisfactory solution of health problems.
3. Provide leadership in community health programs.
4. Secure the cooperation of and work effectively with individuals and agencies.
5. Analyze situations accurately and take effective action.
6. Speak and write effectively.

**ELIGIBLE LIST  
INFORMATION**

A departmental open eligible list will be established for the Department of State Hospitals-Atascadero, Coalinga, Metropolitan, Napa, and Patton. The eligible list will be used to fill vacancies at Atascadero, Coalinga, Metropolitan, Napa, and Patton. Names of successful competitors are merged onto the list in order of final score, regardless of date. Eligibility expires 12 months after it is established, unless the needs of the service and conditions of the list warrant a change in this period.

## GENERAL INFORMATION

**For an examination without a written feature** it is the competitor's responsibility to contact the Department of State Hospitals, Selection Services Unit at (916) 651-8832 three weeks after the application deadline date if she/he has not received a progress notice.

**If a competitor's notice of oral interview** or performance test fails to reach her/him prior to the day of the interview due to a verified postal error, she/he will be rescheduled upon written request.

**State Applications (STD. 678) are available** at the California Department of Human Resources, local offices of the Employment Development Department, the Department of State Hospitals, and accessible on the internet at [www.CalHR.ca.gov](http://www.CalHR.ca.gov).

**If you meet the requirements** stated on this bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Competitors who pass will be ranked according to their scores.

**The Department of State Hospitals** reserves the right to revise the examination plan to better meet the needs of the service if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service law and rules and all competitors will be notified.

**Examination Locations:** When a written test is part of the examination, it will be given in such places in California as the number of competitors and conditions warrant.

**Eligible Lists:** Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) subdivisional promotional, 2) departmental promotional, 3) multidepartmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on this bulletin.

**General Qualifications:** Competitors must possess essential personal qualifications including integrity, initiative, dependability, good judgment and ability to work cooperatively with others; and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

**Veterans' Preference:** Effective January 1, 2014, in accordance with Government Codes 18973.1 and 18973.5, Veterans' Preference will be awarded as follows: 1) Any veteran, widow or widower of a veteran, or spouse of a 100 percent disabled veteran, who achieves a passing score in an entrance examination, shall be ranked in the top rank of the resulting eligibility list. Any veteran who has been dishonorably discharged or released is not eligible for Veterans' Preference. 2) An entrance examination is defined, under the law, as any open competitive examination. And 3) Veterans' Preference is not granted once a person achieves permanent civil service status.

Veteran status is verified by the California Department of Human Resources (CalHR). Directions to apply for Veterans' Preference are on the Veterans' Preference Application (Std. Form 1093), which is available at <http://jobs.ca.gov/Job/VeteransInformation>, and the Department of Veterans Affairs.

**High School Equivalence:** Equivalence to completion of the 12th grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification from the State Department of Education, a local school board, or high school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.

**Career Credits:** In open, nonpromotional examinations, career credits are granted to: 1) State employees with permanent civil service status, 2) full-time employees of the State who are exempt from State civil service pursuant to the provisions of Section 4 of Article VII of the California Constitution, and who meet all qualification requirements specified by the Board and have 12 consecutive months of service in an exempt position, and 3) individuals who have served one full year in, or are graduates of, the California Conservation Corps (eligibility shall expire 24 months after graduation from the California Conservation Corps). Three points are added to the final test score of those candidates who meet the above criteria, and who are successful in the examination. Such examinations cannot be for managerial positions described in Government Code 3513. Competitors not currently employed in State civil service who have mandatory reinstatement rights may also be eligible for career credits, but they must explain their civil service status in the appropriate section of the State Applications (STD. 678).
