## EXAMINATION INFORMATION

This examination consists of Training and Experience Self-Assessment examination weighted 100%. In order to obtain a position on the eligible list, a minimum rating of 70% must be attained.

Testing is considered continuous as exam dates can be set at any time. The testing office will accept applications continuously and will notify and test applicants as needs warrant.

## PREPARING FOR THE EXAMINATION

## **ELIGIBLE LIST INFORMATION**

Names of successful candidates will be merged onto the existing California Prison Industry Authority eligible list in order of final scores regardless of test date. Eligibility expires **12** months after it is established. Competitors must then retest to reestablish eligibility. Competitors may retest after **12** months. The resulting eligibility list will be used to fill vacancies at California Prison Industry Authority. A departmental OPEN eligible list will be established for the California Prison Industry Authority. Eligibility expires **12** months after it is established unless the needs of the service and conditions of the list warrant a change in this period.

## **POSITION DESCRIPTION**

Incumbent maintains vehicle maintenance and safety requirements as per California Vehicle Code (C.V.C) and California Code of Regulations (C.C.R). Title 13; ensures all shop locations comply with all local, State, and federal regulatory laws and regulations, including those set forth by California Department of Corrections and Rehabilitation (CDCR) and California Prison Industry Authority (CALPIA); submits Budget Change Proposal (BCP) and capital request information to designated staff for additional and replacement equipment statewide; conducts employee training to shop staff in accordance with CALPIA's Injury and Illness Prevention Program (IIPP); and maintains vehicle maintenance and safety records in accordance with CHP regulations.

In a repair shop, incumbent instructs journeypersons and helpers in the repair of automobiles, trucks, tracklayers, graders, loaders, cranes, generators, compressors and other related mechanical equipment; inspects incoming equipment to determine repair work needed, estimates cost of repairs, and requisitions or purchases necessary parts; assigns, sets priority, and reviews progress of work; assists with repair and maintenance work as necessary; inspects and tests completed jobs; is responsible for maintaining a stock of supplies and parts and for the care and maintenance of shop tools and equipment; periodically inspects assigned equipment for conformance to agency maintenance standards; instructs and trains personnel in the operation and maintenance of equipment; keeps required records and makes reports; maintains order and supervises the conduct of persons committed to the Department of Corrections and Rehabilitation; prevents escapes and injury by these persons to themselves or others or to property; maintains security of working areas and work materials; inspects and searches premises for contraband, such as weapons or illegal drugs.

## **REQUIREMENTS FOR ADMITTANCE TO THE EXAMINATION**

It is your responsibility to make sure you meet the education and/or experience requirements as stated on this announcement as of the date this test is taken.

## **MINIMUM QUALIFICATIONS**

Qualifying experience may be combined on a proportionate basis if the requirements stated include more than one pattern, distinguished as “either” I, “or” II, “or” III, etc. For example, candidates who possess qualifying experience amounting to 50% of the required time of Pattern I, & additional experience amounting to 50% of the required time of Pattern II, may be admitted to an examination as meeting 100% of the overall experience requirement.

#### **Either I**

Experience: Two years of experience in California state service performing the duties of a Heavy Equipment Mechanic.

#### **Or II**

Experience: Two years of experience within the last five years as a journeyman heavy equipment mechanic. **AND**

Education: Completion of a recognized apprenticeship as an automobile or heavy equipment mechanic.

#### **Or III**

Experience: Five years of experience within the last ten years as a journeyman automobile or heavy equipment mechanic, two years of which must have been as a heavy equipment mechanic, **AND**

Education: Equivalent to completion of the eighth grade. (Additional qualifying experience may be substituted for the required education on a year-for-year basis).

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be accepted into the examination. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

Applications **MUST** contain the following information: “to” and “from” dates (month/day/year), time base, civil service class title(s), and range, if applicable. College course information **MUST** include title, semester, or quarter credits, name of institution, completion dates, and degree (if applicable).

Applications received without this information may be rejected.

**NOTE:** It is especially important that each applicant takes special care to fill out their application accurately and completely. List all experience relevant to the “Minimum Qualifications” shown on this announcement.

#### **PROOF OF EDUCATION**

Applicants using education to meet the minimum requirements must provide a copy of their diploma, official/unofficial transcript, statement and/or evaluation from an accredited U.S. college or university with their examination application. If any applicant is not able to provide proof of education from a recognized institution at the time of appointment, their name may be removed from the eligible list(s).

#### **FOREIGN DEGREES**

Applicants with foreign transcripts must provide an official/unofficial foreign transcript evaluation that indicates the number of units to which his/her foreign course work is equivalent. Tact, patience, and ability to work with persons confined in a correctional institution.

## **SPECIAL PHYSICAL CHARACTERISTICS**

Persons appointed to positions in this class must be reasonably expected to have and maintain sufficient strength, agility, and endurance to perform during stressful (physical, mental, and emotional) situations encountered on the job without compromising their health and well-being of that of their fellow employees. Assignments during tour of duty may include sole responsibility for the supervision of offenders and/or the protection of personal and real property.

## **SCOPE**

In addition to evaluating the competitors' relative abilities as demonstrated by quality and breadth of experience, emphasis on the Qualification Assessment Questionnaire will be on measuring competitively relative to job demands, each competitor's:

### **Knowledge of (with particular reference to Equipment Maintenance Supervisor - Correctional Facility):**

1. Methods, tools, materials, and equipment used in the maintenance and repair of various equipment, both gasoline and diesel, e.g., passenger cars, light and heavy trucks, track laying tractors, and construction equipment to assemble, maintain and/or dismantle various items.
2. Principles and methods of preventive maintenance to achieve CALPIA objectives and apply to various projects.
3. Principles of effective supervision and planning and directing the work of a crew of mechanics and offenders to carry out various work activities.
4. Safety regulations and practices to ensure compliance and a safe working environment.
5. Basic computer skills, including email, document creation, spreadsheets and computer operating systems to ensure efficient record keeping.

### **Skill in (with particular reference to Equipment Maintenance Supervisor - Correctional Facility):**

1. Use of necessary tools and the adjustment and repair of automotive and heavy equipment to efficiently and effectively carry out assignments.

### **Ability to (with particular reference to Equipment Maintenance Supervisor - Correctional Facility):**

1. Inspect equipment, locate defects, and estimate the cost of repairs to determine and implement appropriate courses of action.
2. Read, interpret, and work from plans, drawings, and specifications to facilitate problem resolution.
3. Communicate, plan, and direct the work of a crew of mechanics and offenders to meet project demands and objectives.
4. Train personnel in the proper operation and maintenance of equipment to convey information and

deliver services in a timely manner.

5. Analyze situations and act effectively to facilitate problem resolution and provide program support.
6. Keep necessary records and make reports to provide summary information.

## VETERAN'S PREFERENCE

Veterans' Preference will be granted for this examination. In accordance with Government Code 18793.1 and 18973.5, whenever any veteran, or widow or widower of a veteran, achieves a passing score on an open examination, they shall be ranked in the top rank of the resulting eligibility list.

## GENERAL INFORMATION

**California Prison Industry Authority** reserves the right to revise the examination plan to better meet the needs of the service if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service law and rules and all competitors will be notified accordingly.

**For an examination without a written feature**, it is the candidate's responsibility to contact the California Prison Industry Authority at (916) 358-2696 three weeks after the final filing date if he/she has not received a progress notice.

**If you meet the requirements**, you may take this examination, which is competitive. Possession of the entrance requirement does not assure a place on the eligible list.

**Applications are available** at California Department of Human Resources (CalHR), local offices of the Employment Development Department, the California Prison Industry Authority-Human Resources, and online at [www.calpia.ca.gov](http://www.calpia.ca.gov).

**Eligible Lists:** Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on this bulletin.

**General Qualifications:** Applicants must possess essential personal qualifications, including integrity, initiative, dependability, good judgment, and ability to work cooperatively with others; and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and

personal history and fingerprinting may be required.

**Background Investigation:** If you are successful in this examination, you may be required to complete a background investigation form disclosing information on arrests and driving violations. Candidates will be fingerprinted to search fingerprint files to disclose any criminal record. The hiring agency will use this information to determine your suitability to become a CALPIA employee. Information collected for a background investigation is distinct from that required on the Examination Application (STD 678) which is completed prior to the examination. You will be required to divulge arrest and/or conviction information on the background investigation document that is not required when completing the Examination Application.

**High School Equivalence:** Equivalence to completion of the 12th grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification from the State Department of Education, a local school board, or high school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.
