Applicants who meet the minimum qualifications (entrance requirements) in this announcement and who have not taken the examination in the last **12** months may apply for this examination.

EXAMINATION INFORMATION

This examination consists of Training and Experience Self-Assessment examination weighted 100%. In order to obtain a position on the eligible list, a minimum rating of 70% must be attained.

Testing is considered continuous as exam dates can be set at any time. The testing office will accept applications continuously and will notify and test applicants as needs warrant.

PREPARING FOR THE EXAMINATION

ELIGIBLE LIST INFORMATION

Names of successful candidates will be merged onto the existing California Prison Industry Authority eligible list in order of final scores regardless of test date. Eligibility expires **12** months after it is established. Competitors must then retest to reestablish eligibility. Competitors may retest after **12** months. The resulting eligibility list will be used to fill vacancies at California Prison Industry Authority. A departmental OPEN eligible list will be established for the California Prison Industry Authority. Eligibility expires **12** months after it is established unless the needs of the service and conditions of the list warrant a change in this period.

POSITION DESCRIPTION

A Heavy Truck Driver (Correctional Facility) drives a truck-tractor with semi-trailer or truck and trailer equipment; hauls material, supplies, and equipment between distant points; loads and unloads or supervises the loading and unloading of assigned equipment, limiting the load to a safe capacity; has trucks serviced and checked at regular intervals and keeps trucks in clean and serviceable condition; changes tires, makes emergency adjustments to the truck and motor and reports defects to supervisors; keeps records and makes reports as required; incumbent also maintains order and supervises the conduct of persons committed to the California Department of Corrections and Rehabilitation; prevents escapes and injury by these persons or others or to property; maintains security of working areas and work materials; inspects and searches inmates or wards for contraband, such as weapons or illegal drugs. This position is subject to the Department of Transportation (DOT) random drug/alcohol testing in accordance with Federal Law and will be included in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) Program. **NOTE:** Possession of a doubles/triples endorsement and a HazMat endorsement is desired.

REQUIREMENTS FOR ADMITTANCE TO THE EXAMINATION

It is your responsibility to make sure you meet the education and/or experience requirements as stated on this announcement as of the date this test is taken.

MINIMUM QUALIFICATIONS

Qualifying experience may be combined on a proportionate basis if the requirements stated include more than one pattern, distinguished as "either" I, "or" II, "or" III, etc. For example, candidates who possess qualifying experience amounting to 50% of the required time of Pattern I, & additional experience amounting to 50% of the required time of Pattern II, may be admitted to an examination as meeting 100% of the overall experience requirement.

Possession of a California driver's license valid for the operation of any combination of vehicles.

One year of experience (within the last ten years) in the operation of heavy compound transmission motor truck-tractors with semi-trailer or heavy motor truck and trailer equipment.

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be accepted into the examination. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

Applications MUST contain the following information: "to" and "from" dates (month/day/year), time base, civil service class title(s), and range, if applicable. College course information MUST include title, semester, or quarter credits, name of institution, completion dates, and degree (if applicable).

Applications received without this information may be rejected.

PROOF OF EDUCATION

Willingness and ability to do heavy manual labor.

SPECIAL PHYSICAL CHARACTERISTICS

Persons appointed to positions in this class must be reasonably expected to have and maintain sufficient strength, agility, and endurance to perform during stressful (physical, mental, and emotional) situations encountered on the job without compromising their health and well-being or that of their fellow employees or that of inmates. Assignments during tour of duty may include sole responsibility for the supervision of inmates and/or the protection of personal and real property.

SCOPE

In addition to evaluating the competitors' relative abilities as demonstrated by quality and breadth of experience, emphasis on the Qualification Assessment Questionnaire will be on measuring competitively relative to job demands, each competitor's:

Knowledge of (with particular reference to Heavy Truck Driver (Correctional Facility):

- 1. Operation and servicing requirements of truck tractor with semitrailer or truck and trailer equipment using compound transmissions to safely and efficiently transport CALPIA products.
- 2. Weight limitations/distribution to safely and legally operate within California Highway Patrol, Department of Transportation (DOT) limits.
- 3. Laws pertaining to length restrictions to legally operate in accordance with California Highway Patrol, Department of Transportation (DOT), and local ordinances.
- 4. Provisions of the California vehicle code and all applicable laws applied to the operation of vehicles on the highway.

Skill in (with particular reference to Heavy Truck Driver (Correctional Facility):

- 1. Recognize and take necessary precautions against hazardous driving conditions to effectively deliver CALPIA products on time.
- 2. Drive in a smooth, careful, and safe manner to ensure public safety and maintain the integrity of CALPIA freight.
- 3. Make adjustments and emergency repairs to equipment operated to efficiently and effectively complete assignments and meet delivery schedules.
- 4. Properly load and unload equipment/cargo and when necessary direct helpers to safely and efficiently complete work assignments.
- 5. Follow oral and written directions to effectively complete work assignments.
- 6. Keep necessary records and make reports to ensure the integrity, quality, and validity of collected data.

VETERAN'S PREFERANCE

Veterans' Preference will be granted for this examination. In accordance with Government Code 18793.1 and 18973.5, whenever any veteran, or widow or widower of a veteran, achieves a passing score on an open examination, they shall be ranked in the top rank of the resulting eligibility list.

GENERAL INFORMATION

California Prison Industry Authority reserves the right to revise the examination plan to better meet the needs of the service if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service law and rules and all competitors will be notified accordingly.

For an examination without a written feature, it is the candidate's responsibility to contact the California Prison Industry Authority at (916) 358-2696 three weeks after the final filing date if he/she has not received a progress notice.

If you meet the requirements, you may take this examination, which is competitive. Possession of the entrance requirement does not assure a place on the eligible list.

Applications are available at California Department of Human Resources (CalHR), local offices of the Employment Development Department, the California Prison Industry Authority-Human Resources, and online at www.calpia.ca.gov.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on this bulletin.

General Qualifications: Applicants must possess essential personal qualifications, including integrity, initiative, dependability, good judgment, and ability to work cooperatively with others; and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Background Investigation: If you are successful in this examination, you may be required to complete a background investigation form disclosing information on arrests and driving violations. Candidates will be fingerprinted to search fingerprint files to disclose any criminal record. The hiring agency will use this information to determine your suitability to become a CALPIA employee. Information collected for a background investigation is distinct from that required on the Examination Application (STD 678) which is completed prior to the examination. You will be required to divulge arrest and/or conviction information on the background investigation document that is not required when completing the Examination Application.

High School Equivalence: Equivalence to completion of the 12th grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification form the State Department of Education, a local school board, or high school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.
