MINIMUM QUALIFICATIONS

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be accepted into the examination. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

Associate Hydroelectric Power Utility Engineer

Graduation from college with major work in electrical, electronic, mechanical, or civil engineering. (Additional qualifying experience may be substituted for the required education on a year-for-year basis.) **and**

Either I

Two years of engineering experience in the electric utilities field and/or in the operation and maintenance of pumping and generating equipment at the Electrical Engineer, Range B, or Mechanical Engineer, Range B, level in California state service.

Or II

Three years of engineering experience in the electric utilities field and/or in the operation and maintenance of pumping and generating equipment, at least two years of which shall have been comparable in responsibility to that of an Electrical Engineer, Range B, or Mechanical Engineer, Range B, in California state service.

POSITION DESCRIPTION

Associate Hydroelectric Power Utility Engineer

This is the full journey level. Under direction, incumbents perform difficult engineering work relating to the electric utilities field and/or operation and maintenance of pumping and generating equipment, and other related work.

EXAMINATION SCOPE

This examination consists of the following components:

Training and Experience Evaluation – Weighted 100% of the final score.

The examination will consists solely of a **Training and Experience Evaluation.** To obtain a position on the eligible list, a minimum score of 70% must be received. Applicants will receive their score upon completion of the Training and Experience Evaluation process.

A final score of 70% must be attained to be placed on the eligible list.

In addition to evaluating applicants' relative knowledge, skills, and ability, as demonstrated by quality and breadth of education and/or experience, emphasis in each exam component will be measuring competitively, relative job demands, each applicant's:

Knowledge:

- 1. Knowledge of engineering theory and practices relating to power generation, transmission, distribution, and marketing.
- 2. Knowledge of electric utility operation and management.
- Knowledge of functions, responsibilities, and procedures of regulatory and government agencies (e.g., Public Utilities Commission, the Federal Energy Regulatory Commission, and the California Energy Commission) in the electric field.
- 4. Knowledge of planning, design, construction, and operation of major generating plants, power transmission systems and pumping plants.
- 5. Knowledge of methods of determining the optimum capacity and energy output of generating plants.
- 6. Knowledge of power marketing and economics, including the market for and value of electric power, methods of marketing power and rates, agreements.
- 7. Knowledge of methods of operating, maintaining, and testing of electrical and mechanical equipment and systems for plants, switchyards, reservoir outlets and aqueduct control features.
- 8. Knowledge of environmental issues and policies.
- 9. Knowledge of unit operating and loading procedures and criteria.
- 10. Knowledge of standards of the American National Standards Institute, Institute of Electrical and Electronic Engineers, and American Society of Mechanical Engineers.
- 11. Knowledge of instrumentation and control circuitry and electrical protection.
- 12. Knowledge of servo systems and governors.
- 13. Knowledge of bearings.
- 14. Knowledge of lubrication.
- 15. Knowledge of metal working.
- 16. Knowledge of machining and welding.
- 17. Knowledge of nondestructive examination.
- 18. Knowledge of alignment and balancing of rotating machinery including vibration measurement.
- 19. Knowledge of methods of maintenance, repair and testing.
- 20. Knowledge of power system operation and control.
- 21. Knowledge of power system studies, load flow, stability, and fault analyses.

Ability:

- 22. Ability to analyze situations accurately and adopt an effective course of action.
- 23. Ability to prepare clear and concise reports.
- 24. Ability to prepare procedures and manuals.
- 25. Ability to make feasibility studies.
- 26. Ability to interpret, prepare, and revise electrical and mechanical drawings and schematics and relay control logic diagrams.
- 27. Ability to assist and advise others on maintenance and repair procedures, materials, and tools.
- 28. Ability to negotiate, administer, and coordinate contracts such as for maintenance, repair, testing, and consultation.
- 29. Ability to conduct and coordinate special test activities.
- 30. Ability to use personal computers.

ELIGIBLE LIST INFORMATION

A departmental, open eligible list for the **Associate Hydroelectric Power Utility Engineer** classification will be established for:

The names of **successful** competitors will be merged onto the eligible list in order of final score regardless of exam date. Eligibility expires **twelve (12) months** after it is established. Applicants must then retake the examination to reestablish eligibility. Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described in this bulletin will be rated against a predetermined job-related rating, and all applicants who pass will be ranked according to their score.

The Department of Water Resources reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

General Qualifications: Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.
